#### 8. **DUTIES OUTSIDE THE COUNTRY**:

I was selected to represent Kenya to develop a Procurement Legal Framework that would be consistent with UNICITRAL law model and also appropriate for COMESA countries. Countries chosen by the COMESA Secretary General's office in Lusaka, Zambia were Uganda, Kenya, Ethiopia, DRC Congo, Egypt, Zambia and Malawi. The team became the technical committee and I was appointed the chair. With the exception of

DRC Congo, the rest of the countries have since written their procurement Laws based on the model that my team developed.

#### 9. PAPERS PRESENTEED:

- a) After retirement from the Civil Services, I was invited to present a paper on "Enhancing Objectivity through Big Data in SCM", -
- b) In November, 2016, at the annual East African Procurement Forum held in Kigali, Rwanda, I presented a paper on "The Growing Procurement Profession in East Africa".
- c) In 2009, in a Conference largely sponsored by the African Development Bank (AfDB) on Procurement for African Countries held in Tunis, Tunisia, I presented a paper on "Inadequate Application of Leasing Option in Procurement".

#### 10.TASK FORCES:

Whereas the Civil Service exposes one to a variety of task forces, in my case the most memorable ones are those concerned with the development of procurement policies, laws and regulations. On these, I participated on the following:

- a) In the years 2000 and 2001, I represented the Training Institutions in developing policy and eventually Regulations with the support of the World Bank. The result of this was the production of "Public Procurement and Disposal regulations" gazetted by the Minister for Finance in December 2001.
- b) After the regulations, I was incorporated in the team that made the zero draft of the Public Procurement and Disposal Act (2005) before the same was processed as usual through the office of the Hon. Attorney General (A.G) with the subsequent approval of the Cabinet.
- c) Upon the promulgation of the current Kenya Constitution in 2010, it so happened that Procurement Act was one of the Laws directed by the Constitution to be reviewed within a time line of four years. I was recalled to the PPD/National Treasury, as Deputy Director SCM, in 2013 to spearhead this exercise. Working closely with the Director

PPD/Treasury, I spearheaded the exercise of reviewing the PP&D Act. Due to a variety of challenges, the constitutional timeline was not observed. However, with constitutional provisions, Parliament extended the deadline for the first and last time. Eventually, the President signed into the Law the "Public Procurement &Assets Disposal (PP&AD) Act 2015. The same was operationalized on 7<sup>th</sup> January, 2016.

d) With the Law in place, it became necessary to provide for Attendant Regulations. Again, I was appointed to the "Task Force" that prepared "PP&AD" Regulations 2020. I was retained to the task force even after retirement.

#### 11.POST RETIREMENT ACTIVITIES:

I continue to engage in various activities of SCM. A few of those include:

- a) Being invited and attending a World Bank Training of Trainers mainly on matters of Devolution held in May 2018 Venue Kigali, Rwanda.
- b) Participated in public procurement audit of County Governments through the Public Procurement Regulatory Authority (PPRA).
- c) Sat in the Examinations Committee of the professional exams conducted by the professional body, KISM (Kenya Institute of Supplies Management).
